We have read and reviewed the comments provided during the PLUS Review of the Herola Family Property project on August 22, 2012, and received from the Office of State Planning in a letter dated September 19, 2012. We offer the following item-by-item response narrative for your review:

Strategies for State Policies and Spending

This parcel is within a Level 2 area according to the 2010 Strategies for State Policies and Spending document. Investment Level 2 reflects areas where growth is anticipated by local, county, and State plans in the near term future. State investments will support growth in these areas. Our office has no objections to the proposed rezoning of this project in accordance with the relevant county codes and ordinances. If the rezoning is approved, the State asks that the following comments regarding development of the site be considered:

Code Requirements/Agency Permitting Requirements

State Historic Preservation Office – Contact Terrence Burns 736-7404

- *There are no known historic resources, such as archeological sites or National Register listed properties on this parcel. However, if there is going to be any type of residential or commercial development plans in the future, the developer should also be aware of Delaware's Unmarked Human Burials and Human Skeletal Remains Law, which is outlined in Chapter 54 of Title 7 of the Delaware Code.*

- *Abandoned or unmarked family cemeteries are very common in the State of Delaware, and often they are either on or near a historic farm site, in rural areas or open space lands. Disturbing unmarked burials triggers Delaware's Unmarked Human Burials and Human Skeletal Remains Law (Delaware Code Title 7, Chapter 54), and such remains or discoveries can result in substantial delays while the procedures required under this law are carried out. The Division of Historical & Cultural Affairs recommends that owners and/or developers have a qualified archaeological consultant investigate their project area for the presence of such a cemetery. If a cemetery is discovered, it is very costly to have it archaeologically excavated and the burials moved. In the event of such a discovery, the Division of Historical & Cultural Affairs recommends that the plans be re-drawn to leave the cemetery on its own parcel or in the open space area of the development, with the responsibility for its maintenance lying with a homeowners association or development. We thank the State Historic Preservation Office for the information regarding the above mentioned parcel. The developer is aware of Delaware's Unmarked Human Burials and Human Skeletal Remains Law and will comply with requirements should they pertain to this site. If the developer encounters any archaeological sites they will call State Historic Preservation Office.

- *Prior to any demolition or ground disturbing activities, the developer should consider hiring an archaeological consultant to examine the parcel for archaeological sites, such as a cemetery or unmarked human remains. Furthermore, if there is any federal involvement with the project, in the form of licenses, permits, or funds, the federal agency, often through its client, is responsible for complying with Section 106 of the National Historic Preservation Act (36 CFR 800) and must consider their project's effects on any known or potential cultural or historic resources. Owners and developers who may plan to apply for an Army Corps of Engineers permit or for federal funding, such as HUD or USDA grants, should be aware of the National Historic Preservation Act of 1966 (as amended). Regulations promulgated for Section 106 of this Act stipulate that no ground-disturbing or demolition activities should take place before the Corps or other involved federal agency determines the area of potential effect of the project undertaking. These stipulations are in place to allow for comment from the public, the Delaware State Historic Preservation Office, and the Advisory Council for Historic Preservation about the project's effects on historic properties. Any preconstruction activities without adherence to these stipulations may jeopardize the issuance of a permit or receipt of funding if it is determined that such opportunity to comment has been foreclosed. If you need further information or additional details pertaining to the Section 106 process and the Advisory Council's role, please review the Advisory Council's website at www.achp.gov.*

Preplanning activities for this project will involve making a detailed delineation and survey of state and federally regulated wetlands and waters boundaries. The project will be designed to avoid impacts to both state and federally regulated wetlands. In the event that

regulated activities are proposed requiring a permit from the Corps of Engineers or other federal agency, the developer will consult with those agencies to determine the area of potential effects. As determined by the Section 106 process, the developer will then retain a qualified archaeologist to perform any required site evaluations or studies offsite for possible impact to historic or cultural resources.

Department of Transportation – Contact Bill Brockenbrough 760-2109

- *DelDOT has not received a Service Level Evaluation Request from Sussex County regarding the proposed rezoning but we understand that one may be sent to us soon. In accordance with the traffic volume warrants found in Section 2.3.1 of our Standards and Regulations for Subdivision Streets and State Highway Access, it may be appropriate for the County to require a Traffic Impact Study before acting on the rezoning application. However, depending on the content of that Request, a sufficient study may already have been done.*
- *In 2011, working with the applicant and the owner of the adjoining Warrington Property, DelDOT conducted a study of 11 intersections in the Old Landing Road Area. That study examined a specific development scenario that included full development of the pad sites along Route 24 with office uses, a Discount Superstore on the subject land, a mix of retail uses on the Warrington Property, and a network of local roads connecting these properties to Delaware Route 24 and Old Landing Road. The connection to Old Landing Road would involve lands not controlled by the applicant. The study found that in 2014, with the completion of the proposed development, the local roads and DelDOT's planned widening of Route 24 (now scheduled to be complete in the spring of 2015) most intersections would operate acceptably. The study also identified four areas of concern, that would need to be addressed through further analysis, and possibly improvements not included in DelDOT projects. These were the Beebe Hospital and Wal-Mart access drives on Route 24, and the intersection of Old Landing Road and Airport Road, all of which would connect to the local road network just mentioned, and Airport Road itself, which would need to be improved to accommodate the increased traffic.*
- *If the Service Level Evaluation Request indicates that development of the property would include the connection to Old Landing Road, we are prepared to recommend to Sussex County that they act based on our Old Landing Road Study, with a requirement that the local road network be constructed and that the locations mentioned above be the subject of a Traffic Operational Analysis to be done, and additional improvements to be determined, at the time that a specific development proposal is known.*
- *If the Service Level Evaluation Request does not indicate that development of the property would include the connection to Old Landing Road, we would likely recommend that further analysis, on the level of a Traffic Impact Study, be required prior to a decision on the rezoning. While we would make our files from the Old Landing Road study available to the applicant, and we would expect to review and comment on their work, we are not presently prepared to undertake new work in this regard.*

A scoping meeting will be requested by Davis, Bowen & Friedel, Inc. to discuss the previously conducted analysis around the site and to determine if a TOA or further analysis is required.

State subaqueous lands include all tidal waters (up to the mean high water line), most non-tidal rivers, streams, lakes, ponds, bays and inlets (up to the ordinary high water line), most perennial streams and ditches and many intermittent streams and ditches. We thank you for providing us with the above information. In the event wetlands are encountered a Professional Wetland Scientist will be obtained to conduct the detailed delineation of the state and federally regulated waters and wetlands.

TMDLs

- *The project is located in the low nutrient reduction zone of the greater Inland Bays watershed. In this watershed, Total Maximum Daily Load (TMDL) pollutant reduction targets have been developed by the State of Delaware (under the auspices of Section 303(d) of the 1972 Federal Clean Water Act) for nutrients (e.g., nitrogen, phosphorus), and bacteria. A TMDL is the maximum level of pollution allowed for a given pollutant below which a "water quality limited water body" can assimilate and still meet State water quality standards (e.g., dissolved oxygen, nutrients, and bacteria; State of Delaware Surface Water Quality Standards, as amended July 11, 2004) to the extent necessary to support use goals such as, swimming, fishing, drinking water and shell fish harvesting. The TMDL for the low reduction zone of the Inland Bays watershed calls for 40 percent reduction in nitrogen and phosphorus from baseline conditions. The TMDL also calls for a 40 percent reduction in bacteria from baseline conditions.*
- *A nutrient management plan is required under the Delaware Nutrient Management law (3 Del. Chapter 22) for all persons or entities who apply nutrients to lands or areas of open space in excess of 10 acres. This project's open space may exceed this 10-acre threshold. Please contact*

- *The adopted Inland Bays Pollution Control Strategy regulation was published in the Delaware Register of Regulations on November 11, 2008 and is now an enforceable regulatory directive. A Pollution Control Strategy (PCS) is an implementation strategy that identifies the actions necessary (regulatory and nonregulatory) to systematically reduce the pollutant loading to a given water body, and meet the TMDL reduction requirements specified for that water body. We thank you for providing us with the required reductions for this site. A nutrient management plan will be prepared for this project should it meet the threshold for requiring the plan during construction document preparation. The site will comply with the Inland Bays Pollution Control Strategy Regulations.


Water Supply

- *The project information sheets state water will be provided to the project by Tidewater Utilities via a central water system. Our records indicate that the project is located within the public water service area granted to Tidewater Utilities under Certificate of Public Convenience and Necessity 83-W-15.*
- *Should dewatering points be needed during any phase of construction, a dewatering well construction permit must be obtained from the Water Supply Section prior to construction of the well points. In addition, a water allocation permit will be needed if the pumping rate will exceed 50,000 gallons per day at any time during operation.*
- *All well permit applications must be prepared and signed by licensed water well contractors, and only licensed well drillers may construct the wells. Please factor in the necessary time for processing the well permit applications into the construction schedule. Dewatering well permit applications typically take approximately four weeks to process, which allows the necessary time for technical review and advertising.*

We will obtain a ‘Willing and Able’ letter from Tidewater Utilities, Inc. for the project. Well permits will be obtained if needed for dewatering and in accordance with all rules and regulations.

Water Resource Protection Areas

- *The DNREC Water Supply Section, Ground-Water Protection Branch (GPB) has determined that the parcel falls within close proximity to five wellhead protection areas for Sussex County (see map). The wellhead protection areas protect wells owned by Tidewater Utilities Lewes-Rehoboth District and the City of Rehoboth.*
- *Wellhead protection areas are surface and subsurface areas surrounding a public water supply well where land use activities or impervious cover may adversely affect the quantity and quality of ground water moving toward such wells.*
- *As these wells increase production to meet the needs of the population they serve, the size of wellhead protection areas will likely increase. Impervious cover resulting from commercial facilities has the potential to decrease groundwater recharge and increase runoff that may spill into the adjacent wellhead protection areas. Chapter 115 Zoning Article IV §115-19 Of the Sussex County's Code states in part that agricultural districts are also intended for protection of water resources. This parcel is zoned as an agricultural district and the drinking water supply would be afforded more protection if it remains agricultural.*



Sediment and Stormwater Program

- *A detailed sediment and stormwater plan will be required prior to any land disturbing activity taking place on the site. Please contact the reviewing agency to schedule a project application meeting to discuss the sediment and erosion control and stormwater management components of the plan as soon as practicable. The site topography, soils mapping, pre- and post-development*

runoff, and proposed method(s) and location(s) of stormwater management should be brought to the meeting for discussion. The plan review and approval as well as construction inspection will be coordinated through the Sussex Conservation District. Contact Jessica Watson at the Sussex Conservation District at (302) 856-2105 for details regarding submittal requirements and fees. (Title 7, Delaware Code, Chapter 40 and Delaware Regulations, Title 7, Administrative Code, 5101)

Our office will contact the District to schedule a pre-design meeting and will coordinate with the District through design and construction of the project.

Hazardous Waste Sites

- *DNREC's Site Investigation and Restoration Section (SIRS) has reviewed the proposed project. If it is determined by the Department that there was a release of a hazardous substance on the property in question and the Department requires remediation pursuant to the Hazardous Substance Cleanup Act, the provisions of 7 Del.C., Chapter 91, Delaware Hazardous Substance Cleanup Act and the Delaware Regulations Governing Hazardous Substance Cleanup shall be followed.*

The Owner/Developer will perform mediation if a release of hazardous material is determined by the Department.

Tank Management Branch. Please be aware:

- *If a release of a Regulated Substance occurs at the proposed project site, compliance of 7 Del.C., Chapter 60, 7 Del.C., Chapter 74 and DE Admin. Code 1351, State of Delaware Regulations Governing Underground Storage Tank Systems (the UST Regulations) is required.*
- *Per the **UST Regulations: Part E, § 1. Reporting Requirements:***
 - *Any indication of a Release of a Regulated Substance that is discovered by any Person, including but not limited to environmental consultants, contractors, utility companies, financial institutions, real estate transfer companies, UST Owners or Operators, or Responsible Parties shall be reported within 24 hours to:*
 - *The Department's 24-hour Release Hot Line by calling 800-662-8802; and*
 - *The DNREC, Tank Management Section by calling 302-395-2500.*

We thank the branch for providing us with regulations/requirements. The project will comply with all requirements regarding reporting and releases of Regulated Substance if any are encountered.

Delaware State Fire Marshall's Office – Contact Duane Fox 739-4394

At the time of formal submittal, the applicant shall provide; completed application, fee, and three sets of plans depicting the following in accordance with the Delaware State Fire Prevention Regulation (DSFPR):

- **Fire Protection Water Requirements:**
 - Water distribution system capable of delivering at least 1000 gpm for 2-hour duration, at 20-psi residual pressure is required. Fire hydrants with 800 feet spacing on centers.
 - Where a water distribution system is proposed for a Business Office sites, the infrastructure for fire protection water shall be provided, including the size of water mains for fire hydrants and sprinkler systems.
- **Fire Protection Features:**
 - Buildings greater than 10,000 sq. ft., 3-stories or more, over 35 feet, or classified as High Hazard, are required to meet fire lane marking requirements. The Fire Lanes and Sign Detail as indicated in Delaware State Fire Prevention Regulations must be shown.
- **Accessibility**
 - All premises, which the fire department may be called upon to protect in case of fire, and which are not readily accessible from public roads, shall be provided with suitable gates and access roads, and fire lanes so that all buildings on the premises are accessible to fire apparatus.
 - Fire department access shall be provided in such a manner so that fire apparatus will be able to locate within 100 ft. of the front door.
 - The use of speed bumps or other methods of traffic speed reduction must be in accordance with Department of Transportation requirements.
 - The local Fire Chief, prior to any submission to our Agency, shall approve in writing the use of gates that limit fire department access into and out of the development or property.
- **Gas Piping and System Information:**
 - Provide type of fuel proposed, and show locations of bulk containers on plan.
- **Required Notes:**
 - Provide a note on the final plans submitted for review to read “ All fire lanes, fire hydrants, and fire department connections shall be marked in accordance with the Delaware State Fire Prevention Regulations”
 - Proposed Use
 - Alpha or Numerical Labels for each building/unit for sites with multiple buildings/units
 - Square footage of each structure (Total of all Floors)
 - National Fire Protection Association (NFPA) Construction Type
 - Maximum Height of Buildings (including number of stories)
 - Note indicating if building is to be sprinklered
 - Name of Water Provider
 - Letter from Water Provider approving the system layout

- *Provide Lock Box Note (as detailed in DSFPR) if Building is to be sprinklered*
- *Provide Road Names, even for County Roads*

We thank the State Fire Marshal's Office for providing us with regulations/requirements. Davis, Bowen & Friedel, Inc. will schedule a preliminary meeting with a fire protection specialist prior to formal submittal.

Recommendations/Additional Information

Additional information on TMDLs and water quality.

- *Wherever practicable, the applicant is strongly encouraged to use plantings of native trees/shrubs and/or native herbaceous vegetation instead of nonnative "turf grasses" in areas of open space.*
- *The applicant should calculate post-construction surface imperviousness with all forms of created (or constructed) surface imperviousness (e.g., rooftops, driveways, parking lots, sidewalks, open-water storm water management structures, and roads) included in the calculation.*

The post construction impervious area will be discussed with the Sussex Conservation District to determine the appropriate area for stormwater management purposes.

- *Since this is a large project that will likely generate a great amount of impervious cover, we strongly advise the use of pervious paving materials (instead of conventional asphalt and concrete) as a BMP to reduce the impacts associated with surface imperviousness, wherever practicable.*

Pervious pavements may be considered for the use but unlikely to be installed due to cost of materials and installation.

- *We recommend the use of rain gardens, and green-technology storm water management structures (in lieu of open-water management structures) as BMPs to mitigate or reduce nutrient and bacterial pollutant impacts via runoff from impervious surfaces.*

BMPs and BATs will be evaluated in addition to the open water management structures and implemented where possible and feasible.

- *The applicant should voluntarily assess nutrient and bacterial pollutant loading at the preliminary project design phase. To this end, the Watershed Assessment Section has developed a methodology known as the "Nutrient Load Assessment protocol." The protocol is a tool used to assess changes in nutrient (e.g., nitrogen and phosphorus) and bacterial loading that result from the conversion of individual or combined land parcels to a different land use(s), while providing applicants with quantitative information about their project's impact(s) on baseline water quality. We encourage the applicant/developer use this protocol to help them design and implement the most effective BMPs. Please contact Lyle Jones at 302-739-9939 for more information on the protocol.*

We are aware of the protocol and will use this tool as necessary to comply with the Inland Bays PCS.

Additional information on hazardous waste sites

- *SIRS strongly recommends that the land owner perform environmental due diligence of the property by performing a Phase I Environmental Site Assessment (including a title search to identify environmental covenants) in accordance to Section 9105(c) (2) of the Delaware Hazardous Substance Cleanup Act (HSCA). While this is not a requirement under HSCA, it is good business practice and failure to do so will prevent a person from being able to qualify for a potential affirmative defense under Section 9105(c) (2) of HSCA.*

Additional remediation may be required if the project property or site is re-zoned by the county.

- *Should a release or imminent threat of a release of hazardous substances be discovered during the course of development (e.g., contaminated water or soil), construction activities should be discontinued immediately and DNREC should be notified at the 24hour emergency number (800-662-8802). SIRB should also be contacted as soon as possible at 302-395-2600 for further instructions.*

The property has been owned by the Herola Family or affiliates since the 1700s and they are aware of the environmental issues of the site.

- *When contamination is encountered, PVC pipe materials should be replaced with ductile steel and nitrile rubber gaskets in the contaminated areas.*
- *If any aboveground storage tanks (ASTs) less than 12,500 gallons are installed, they must be registered with the TMS. If any ASTs greater than 12,500 gallons are installed, they are also subject to installation approval by the TMS.*

We thank the branch for providing us with the known LUST. The project will comply with all requirements regarding reporting and releases of Regulated Substances.

Additional information on air quality

- *DNREC encourages sustainable growth practices that:*
 - *Control sprawl;*
 - *Preserve rural and forested areas;*
 - *Identify conflicting land use priorities;*
 - *Encourage growth on previously developed sites and denser communities while at the same time protect our diminishing land base;*
 - *Coordinate transportation, housing, environment, and climate protection plans with land use plans; and*


- *Additionally, the following mitigation measures will reduce emissions associated with the actual construction phase of the project:*
 - *Using retrofitted diesel engines during construction. This includes equipment that are on-site as well as equipment used to transport materials to and from site.*
 - *Using pre-painted/pre-coated flooring, cabinets, fencing, etc. These measures can significantly reduce the emission of VOCs from typical architectural coating operations.*
 - *Planting trees at residential units and in vegetative buffer areas. Trees reduce emissions by trapping dust particles and by replenishing oxygen. Trees also reduce energy emissions by cooling during the summer and by providing wind breaks in the winter, whereby reducing air conditioning needs by up to 30 percent and saving 20 to 50 percent on fuel costs.*

This is a partial list, and there are additional things that can be done to reduce the impact of the development. The application should submit a plan to the DAQ which address the above listed measures, and that details all of the specific emission mitigation measures that will be incorporated into the Herola Family Property project.

We have read the additional information comments on air quality.
