#### **MEETING MINUTES**

**Review and Approval of Meeting Minutes from 9/26/2024:** 1<sup>st</sup> Art Jenkins, 2<sup>nd</sup> Tim Lucas. Keith Hall and Dawn Melson-Williams abstained from voting on the minutes.

#### **NEW BUSINESS**

## Yearly Report & Discussion – Ed Ratledge, Dan Blevins

Ed discussed changes to the DPC projections over the last six to seven months. He said most of the 2020 Census data have already been used by DPC, but vital statistics records are now available for 2021 and 2022, and records for 2023 should become available in several months. The updates involve data for the counties on births and deaths, as well as racial and ethnic data and migration. Migration numbers for New Castle and Kent counties are each only around 1,000 people per year, but Sussex County has had a much larger yearly migration number that is partly seasonal. Samantha Bulkilvish asked how DPC numbers will be affected by pending intercensal estimates, and Ed replied those are mainly useful for housekeeping since the 2020 Census numbers cannot be changed.

Dan gave a presentation on the *Delaware Population Forecast—2024 Series Draft*, to compare the DPC projections for 2023 with the 2024 draft. Tables of population by age structure between 2020 and 2050 show little change by age group in New Castle County, but for younger age groups Kent shows a decline and Sussex shows a considerable increase. Sussex also shows a decline in older age groups. Corresponding tables of population by race structure also show little change for racial groups in New Castle County, but noticeable changes in the other counties. A graph of the components of population growth in the State between 2010 and 2050 shows negative natural increase starting around 2026, with net population growth increased somewhat by net migration. Corresponding graphs for the counties also show net migration increasing annual net population growth, which in 2038 becomes negative in New Castle but remains positive through 2050 in the other counties.

Dan's presentation included a table for each county showing historical and forecast municipal population from 2010 through 2050. For each county, these tables show the municipal population as a percentage of the total population remaining fairly constant over time.

Samantha and David Edgell asked why annual net population growth in New Castle County becomes negative around 2038. Dan explained that is due to this county's large number of older persons and their limited life expectancy. Anson Gock asked how life expectancy by gender and county affects birth and death rates. Ed explained the number

of deaths in each age group is known, death rates are based on many factors including age and address, and these rates are updated over time. Ed also mentioned negative population growth in northeastern states due to their older population, and Dan mentioned negative natural increase in many states.

#### **Officer Elections**

Colton said the October DPC meeting is normally the annual meeting, with votes on population projections and officer positions. Because the population projections were not posted soon enough in advance, the vote on them will be postponed until November. He also asked if the votes for officers should also be postponed, and no objections were raised. Matt Rogers made a motion to delay the annual meeting until November, for votes on the projections and the officers. Dan seconded the motion and it passed. Samantha suggested that in the meantime the meeting attendees consider potential nominations for the officer positions.

### **OLD BUSINESS**

## **Bylaws Refresh**

Colton suggested that meeting attendees read over the Bylaws, which are posted on the website, in order to better understand how the Consortium operates.

## **OPEN COMMENT PERIOD**

Samantha said she will take a leave of absence in the spring, and during that time Rose will be the OSPC contact.

### **FUTURE MEETING DATES**

Colton announced the next scheduled DPC meeting will be a special meeting on Thursday, November 14<sup>th</sup>, to vote on officer positions and the final population projection numbers.
