FirstMap 2.0 Update & G-TAC

Kim Cloud – FirstMap 1 servers are officially decommissioned. The upgrade to 10.9.1 was completed on 8/6/22. Advised users to use caution when upgrading to ArcGIS Pro 3.0 as it is a "breaking update". We recommend that users work with their groups/departments and upgrade all at the same time.

Jason Vogl - RFP finalized with Sanborn as the selected vendor. Pilot imagery completed. Next step is to meet as a group to discuss review and processing. If interested contact Jason and he will add you to the list.

Federal Update

<u>Lidar</u>

Roger Barlow- A webinar on the upcoming Broad Agency Announcement (BAA) was held on 8/10/22. Pending the status of the federal budget, they are setup to release the announcement in September and proposals must be submitted within 60 days. Looking at QL2 for Delaware. 2014 was not tide coordinated, so recommends doing tide coordination. Also recommends 30% match for the proposal. Announcement for successful proposals will come out in early December and they prefer having 60 days between signing of the agreement and flight. Delaware is high up in priority because of age and 2014 wasn't 3DEP. Roger noted Northern VA is also getting contours and building outlines at additional cost. Roger will pass along the message that Delaware is planning to apply for the grant.

GIS Data acquisition funding discussion

Jason Vogl and Kim Cloud provided an update on current attempts to secure recurring funding/budget for GIS data collection. The state has ongoing challenges securing funding. We received ARPA funds for a one-time refresh for data and will be submitting for the USGS FY23 BAA grant for Lidar in 2023. They presented a timeline and estimates to help with planning for funding the next round of data collection and encouraged users to work within their departments and with their management to emphasize the importance of the data in the upcoming budget cycle. Jason and Kim will be providing a presentation at the October CCSPI meeting to emphasize the same message with the Cabinet secretaries. At a minimum the State needs to allocate \$135k per year starting in 2023, or \$320k per year to ensure funding is sufficient if grant money is not available.
